

## Job Description Casual School Minibus Driver

The Futures Trust and Hinckley Academy are committed to safeguarding and promoting the welfare of Children and Young People, and require all staff and volunteers to share this commitment.

<b>Responsible to</b>	Designated Line Manager
<b>Hours</b>	Casual work hours will vary £9.25 per hour Initial availability 2 hours per day 7.30-8.30am and 3.00-4.00pm Monday to Friday during term time
<b>Location</b>	Based at Hinckley Academy

### Job Purpose

To oversee the maintenance of and operate the school minibus in a safe manner, ensuring the safety of passengers and other road users at all times.

### Duties and responsibilities

- Daily inspection of the school minibus, prior to setting off on a journey to ensure roadworthiness, serviceability and safety.
- Monitor the cleanliness of the vehicle and the levels of petrol and fluid levels, to ensure efficiency, safety and that the minibus is able to complete each journey.
- Purchase fuel using fuel card and obtain receipts.
- Complete the driver's log prior to and on completion of each journey.
- Report any concerns with regard to the roadworthiness of the vehicle to the designated Line Manager, or in their absence the Operations Manager.
- Drive the school minibus in an appropriate manner with due regard to safety and speed limits and the Highway Code.
- Supervise students on the school minibus, to ensure safety, including checks to ensure seatbelts and head rests are being used appropriately and that the students remain in their seats at all times.
- Enforce the school Behaviour Policy and report of incidents of unsatisfactory behaviour to the designated Line Manager, or in their absence the KS3 or KS4 Director of Learning.
- Collect and drop off students at designated locations and times (before, during and after school hours).
- Advise the designated Line Manager, or in their absence the Operations Manager of any medical issue that would prevent the driver being able to drive.

- Clean the vehicles, including internal and external washing, ensuring that spillages (of any kind) in the vehicle are removed and disinfected as appropriate.
- Administer first aid when required.
- Any other relevant and appropriate occasional duties that may be required by the designated Line Manager/Operations Manager.

### Line management

- The job involves no direct responsibility for the supervision, direction or co-ordination of other employees. The work may involve demonstration of own duties, or providing advice and guidance to new employees or others.

### Professional Development

- Maintain personal professional development to ensure that the knowledge and skills required to fulfill the role of School Minibus Driver are up to date.
- Be a professional role model, and understand and promote the aims of the School and the values of the Trust.

<b>Special conditions of employment</b>
<p><b>Rehabilitation of Offenders Act 1974</b></p> <p>This job is exempt under the Exceptions Orders to the Rehabilitation of Offenders Act 1974. Appointment to this job is subject to an enhanced DBS disclosure being obtained, and any relevant cautions, convictions, bindover orders and warnings being considered.</p> <p>If the jobholder is arrested, summonsed for an offence or receives a conviction a bindover order or a warning given by a police force, they are required to inform the Headteacher of this fact immediately. Such information will be treated in confidence, so far as this is consistent with the safety of children, compliance with statutory child protection procedures and the School's relevant policies. Failure to disclose such information may result in disciplinary action which could lead to the termination of the jobholder's employment.</p>
<p><b>Safeguarding and Promoting the Welfare of Children and Young People</b></p> <p>The jobholder is required to follow all of the School's policies and procedures in relation to safeguarding at all times, and to adhere to the statutory guidance 'Keeping Children Safe in Education'. The jobholder must take appropriate action in the event that they have concerns, or are made aware of the concerns of others, regarding the safety or wellbeing of children or young people.</p>
<p><b>Health and Safety</b></p> <p>The jobholder is required to exercise their duty of care by taking responsibility for their own health and safety, and the health and safety of other people who may be affected by their acts or failure to act. Full guidance regarding health and safety is set out in the School's Health and Safety Policy, and in any risk assessments relevant to the jobholder's role or circumstances. Both can be accessed via the jobholder's line manager, and the jobholder is required to comply with these and to use any protective clothing or equipment as instructed at all times.</p>

### **Confidentiality and Data Protection**

The jobholder is expected to comply with the provisions of the Data Protection Act 2018. Any information they have access to, or are responsible for, must be managed appropriately and any requirements for confidentiality and security observed. Information must not be disclosed to any person or Authority, for example a parent or the Police, without observing the correct procedure for disclosure as set out in the School's Data Protection Policy. Nothing shall prevent the jobholder from disclosing information that they are entitled to disclose under the Public Interest disclosure Act 1998 as amended, provided that the disclosure is made in accordance with the provisions of that Act/s.

### **Equality and Diversity**

The School and the Trust are committed to equality and value diversity. As such the School and the Trust are committed to fulfilling their Equality Duty obligations and expect all employees to share this commitment. The Duty requires the School and Trust to have due regard to the need to eliminate unlawful discrimination, harassment and victimisation, advance equality of opportunity and foster good relations between people who share characteristics, such as age, gender, race and faith, and people who do not share them. The jobholder is required to treat all people they come into contact with, with dignity and respect, and is entitled to expect this in return.

### **Training and Development**

The School has a shared responsibility with the jobholder for identifying and satisfying training and development needs. The jobholder is expected to actively contribute to their continuous professional development and learning, and to attend and participate in any training or development activities required to assist them in fulfilling their role and meeting their safeguarding and general obligations.
