

Message for parents/carers



Dear parents/carers,

You should have received correspondence from us on 29th September 2021 regarding the option to consent to your child to receive a first dose of the COVID-19 vaccination at a specialist session for 12-15-year-olds being held at our school on 6th October.

In order to help answer any of your questions and allow you to make an informed decision with your child regarding the vaccine, Leicestershire Partnership NHS Trust, in collaboration with the Leicester, Leicestershire and Rutland Clinical Commissioning Groups and local authorities, is holding some webinar Q&A sessions for parents.

The webinars, which are being hosted by a panel of health professionals, will include:

- An overview of COVID-19, including the risk of infection
- Information about the Pfizer vaccine being offered
- Details of how the vaccination sessions for young people will be run
- An opportunity for you to ask questions.

More information about for young people and their parents about COVID-19

COVID-19 is a very infectious respiratory disease caused by the SARS-CoV-2 virus. Very few children and young people with COVID-19 infection go on to have severe disease. Vaccinating children should help to reduce the need for children to have time off school and to reduce the risk of spread of COVID-19 within schools.

The COVID-19 vaccination programme in secondary schools will therefore provide protection to children who are vaccinated and help to reduce disruption to face to face education this winter.

***clinically at risk is classified as having any of the following medical conditions:**

- severe neurodisabilities
- immunosuppression – those whose immune systems don't work as well and also those who live with someone who is immunosuppressed
- profound and multiple or severe learning disabilities
- being on the learning disability register
- those living with Down's syndrome
- those living with long term serious conditions affecting their body.
